The Parents Club of S.H.C.S. sponsors the Wine Auction each fall and the Parish/School Social in the spring. The Auction is our large fundraiser of the year, and its success is vital to the school's operation. The Parish/Social event also raises some funds for the school and parish, but is really more of a community builder. Each family is required to work a minimum of two hours on this event and a minimum of 15 hours for the Auction.

The total volunteer hours for the school year remain at 25 hours and the auction and Parish/Social hours are part of this total. Families not fulfilling their hours will be automatically placed in the tuition plan B, the Actual Cost Per Pupil, for the remainder of the current school year. We require that each family sign-up for eScrip, so that we can get as many families as possible involved in this "free" money for our school. There is an annual \$150 scrip fee and a \$25.00 per child technology maintenance fee that is due no later than May 27th.

POLICY OF THE SCHOOL BOARD: Tuition payments are due according to the Smart Tuition payment date you selected. A \$35.00 late fee **per month** will be charged for late tuition by SMART. An early student withdrawal fee of two months tuition will be assessed. Accounts delinquent past 60 days will require a meeting with the principal and pastor.

Volunteer hours are a minimum of 25 per school year; parents who do not fulfill the hours will be placed in Plan B, the Actual Cost Per Pupil charge, for the remainder of the current school year and next school year, if returning. At least 15 of these hours must be devoted to the wine auction and at least two hours to the Parish Social. Registration in the eScrip program is also required along with a \$150 scrip fee per family and a \$25.00 per student technology maintenance fee due no later than May 27th.
